NRG / CPUC Settlement Update

On March 27, 2012, the California Public Utilities Commission announced a \$120 million settlement with NRG Energy where \$100 million will go to be spent on EV charging in the State. Recently, the terms of this settlement have been challenged by ECOtality who claims that the settlement "punishes" NRG by allowing them to invest the settlement money back in their business because NRG would be operating the Fast Chargers that are called for in the settlement

Report on the Electric Vehicle Symposium (EVS26)

On May 6 – 9 the Electric Vehicle Symposium was held at the Los Angeles Convention Center. I did not know much about the EVS before attending so I did not know what to expect. While I did not hear the exact number of attendees, it had to be close to 1,000 but they did announce that people from 47 countries were there. Virtually every major automobile manufacturer had an exhibit and several representatives in attendance. The good news is that I came away with the overwhelming sense that the EV movement is so strong, now, that it would take an incredibly major negative event to stop it. The electric RAV4 was unveiled at the show and most of the major manufacturers had exhibits of their EV(s). You could test drive the eFocus, Leaf, i-MiEV, Volt, Coda, RAV4 (prototype) as well as electric bikes.

SAE also announced the new Fast Charging standard that was approved by both American and European auto manufacturers. This new system is being called "the Combined Charging System". With this system, one vehicle inlet will be able to handle a Level II charge with a J1772 plug as well as a Fast Charge. Note that I did not include the Japanese auto manufacturers in those that approved this new standard. As it turns out, the Combined Charging System has a completely different plug than the CHAdeMO plug and does not have

the same communications protocol as the CHAdeMO system. This means that Fast Chargers that will service all Fast Charging capable EVs will need to have two cords, one with the CHAdeMO plug and one with the Combined Charging System plug.

LOCAL EV ISSUES

Proposed PG&E revision to E-9 Rate Structure

On May 9th, PG&E released its revisions to its "voluntary" Electric Vehicle Schedule E-9. The new rate schedule will be called "Schedule EV". Schedule EV calls for increases in the off peak electric rates. Schedule E-9 will be eliminated no later than December 31, 2014. Customers taking service under Schedule E-9 prior to the effective date of Schedule EV will be "grandfathered" under Schedule E-9 and can keep the E-9 scheduled rates until PG&E is approved to eliminate Schedule E-9. The complete PG&E published revisions are attached to the email that sent this Newsletter.

Note that our July 14th meeting will feature a PG&E representative discussing the rate structures for electric vehicles. DON'T MISS THIS MEETING!!
